## Apprentice Kickstart Bonus

The Federal Government has announced an additional incentive program for employers to take on an apprentice between 1st December 2009 and 28th February 2010.

The scheme is designed for employers of apprentices in a traditional trade, who are 19 years old and under, and commenced in the limited time frame as indicated above. The 'Apprentice Kickstart Bonus' is an additional \$3,350 to the employer paid in two instalments, these are \$850 paid at three months, followed by \$2,500 paid at nine months. This new bonus is in addition to other incentives already available.

Results from a recent national survey of bricklayers found the following:

### Why do employers take on an apprentice?

- Makes good business sense
- An apprentice is more likely to stay with an employer over the 3-4 years
- Because the employer was an apprentice once
- It costs less to employ an apprentice

### Do bricklaying apprentices cost the employer money?

- More than half of bricklayers make money from their 1st year apprentice
- Three-quarters of bricklayers said they made money from their 2nd year apprentice
- Ninety-three percent of bricklayers said they made money from their 3rd year apprentice
